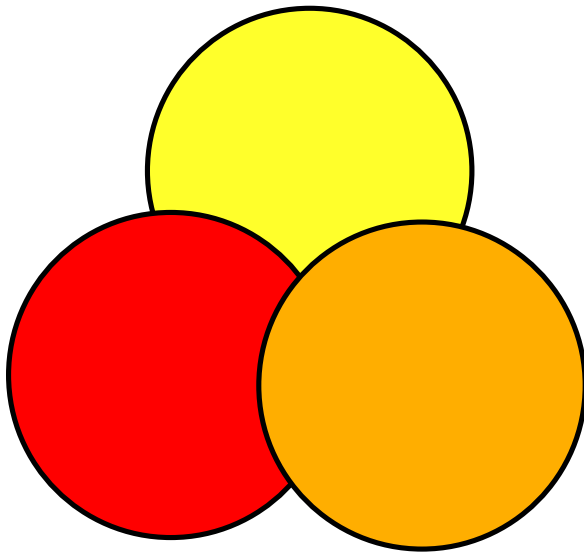

DESCRIPTION

This concentrated, non-flammable anti-static spray is a clear, odorless ionic system. It is a light, sprayable product which is a specially formulated, ready-to-use compound that reduces static electricity on carpeting, plastic and fabric upholstery and other areas where static electricity is a problem. Stops carpet shock and neutralizes static electricity. Will not increase soiling of carpeting. Dries quickly.

APPLICATION

NON STAINING • NON CORROSIVE • NON OILY • NON GREASY

Reduces static electricity on carpeting, plastic and fabric upholstery, plastic parts and equipment, and other areas where static electricity is a problem.

DIRECTIONS

FOR CARPETING: Spray lightly onto the carpet nap. Let the mist fall upon the carpet without wetting or saturating the carpet. A repeat application may be necessary several weeks later. For other applications, apply as a light spray.
