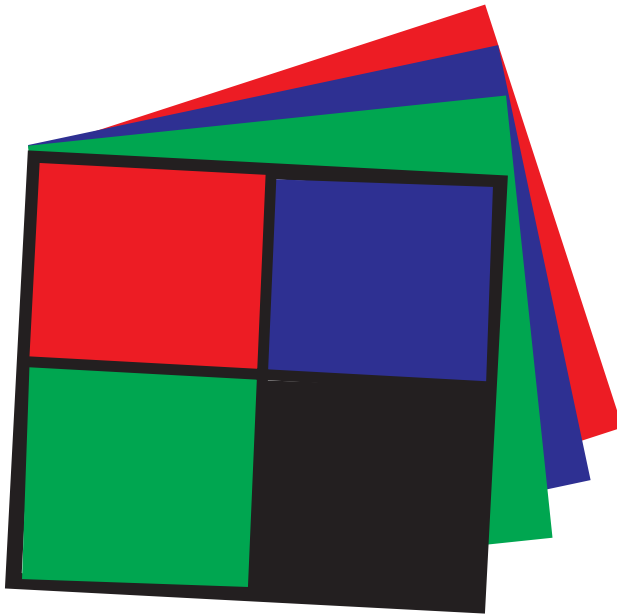

DESCRIPTION

A clear liquid, pine-scented, dual purpose professional product for use on carpets and durable, colorfast upholstery. This product removes oil- and water-base stains from most fabrics prior to shampooing.

APPLICATION

For stains caused by oil, grease, soft drinks, coffee, tea, liquor, food, pets, urine, juices, tar, candy, ink, chocolate, etc.

DIRECTIONS

Pre-Spot Directions

Pour material, full strength, into reservoir of suitable sprayer, and spray directly onto spot or stained area. Shampoo carpet in usual fashion.

SPOTTING DIRECTIONS

Apply full strength to spot or stain. Allow to stand for 3 to 5 minutes. Sponge with clear water and absorb soil with sponge. Dry area by wiping with bath towel or other absorbent cloth. Brush pile with stiff brush.

PRECAUTIONS
