Floor finish removal is accomplished without the use of floor machines, stripping pads and excessive costly labor.

Dilute product accordingly with hot water. Normal stripping: 1 part to 10 parts water (13 oz.

per gal.). Aggressive stripping: 1 part to 5 parts water (26 oz. per gal.). Apply liberally with mop to floor. Be sure to leave surface very wet. Allow to remain 3-4 minutes and remop. Pick up solution using a wet vac. Allow floor to dry thoroughly. No rinsing is necessary if treated surfaces appear free of dust after drying.

Keep out of reach of children. Do not take internally. Do not get in eyes, on skin or on clothing. Wear goggles or face shield and rubber gloves when handling. Do not use product undiluted. Rinse empty container with water and discard. This product is intended for industrial and commercial use and storage by trained service persons only.
