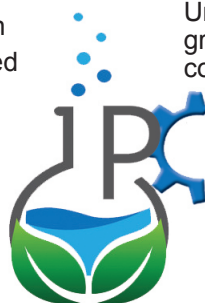

DESCRIPTION

This product is a liquid, nonselective, persistent, general herbicide. It controls annual and perennial broadleaf weeds and grasses. It effectively kills and controls most forms of vegetation. Herbivore will provide residual control for up to 12 months in the treated area.

APPLICATION

Controls hard-to-kill perennial weeds and grasses:

Johnsongrass • Bindweed • Wild Carrot

For bare ground weed control around buildings, storage areas, fences, fuel tanks, recreational areas, pipelines, railroads, highway medians

DIRECTIONS FOR USE

To cover 1200 sq. ft. apply 1 gallon undiluted product by use of hand-operated spray equipment such as backpack sprayers, pump-up sprayers or sprinkling can. Weeds should be growing vigorously at the time of application for maximum herbicide activity.
